## <u>Electronic Visit Verification Update: Alternate EVV Solution Deadline for Compliance</u> THURSDAY, MARCH 4, 2021

To ensure that NC Medicaid meets implementation timelines and can fully integrate EVV through claims adjudication for all providers, alternate EVV Solutions must pass testing validation by March 10, 2021. If the solution has not passed testing by March 10, 2021, provider agencies currently enrolled with their solution may be required to enroll with the State's EVV solution, Sandata, to ensure they are compliant with EVV requirements. More

### <u>Two Months Left to Submit Attestations for Program Year 2020</u> TUESDAY, MARCH 2, 2021

Providers have until April 30, 2021, to submit a complete and accurate attestation for Program Year 2020. After that no changes can be made. More
