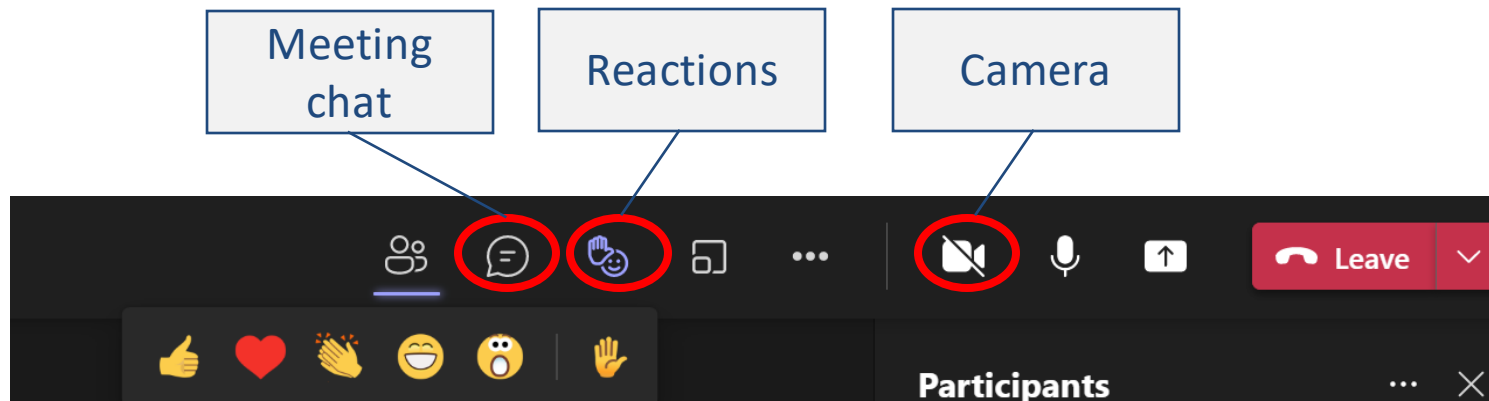

# PHP-AMH Data Transmission Timing Standardization

# PHP-AMH Data Transmission Timing Standardization

## Issue Description and Root Causes

**PHPs have different schedules for sharing the Department's standard data interfaces between them and CIN/AMHs.** Receiving data on differing schedules impacts CIN/AMHs' ability to:

- Efficiently execute downstream processes to provide more complete, accurate, and timely data to their care managers; and
- Provide timely updates to their care management systems, creating a data lag in what is getting reported back to the PHPs.

PHPs have previously raised concerns that their systems are standardized to generate and share data across multiple state Medicaid systems. Tailoring schedules may impact overall system processes already in place.

## Proposed Solution and Next Steps

The Department is **working with PHPs** to identify a potential solution for standardizing the AMH interfaces data transmission timing.

The Department will share additional updates with the Data Subcommittee once the Department and PHPs have aligned on a potential solution that considers all AMH partners' feedback.

# PHP-AMH Care Management Payments Tracking

## Issue Description and Root Causes

**Providers have reported challenges with reconciling their care management payments based on payment data shared with them by Standard Plans.**

Payment reconciliation issues span across multiple care management programs: AMH, CMARC/CMHRP, InCK, and the Healthy Opportunities Pilots.

## Proposed Solution and Next Steps

To address payment reconciliation challenges, the Department is considering a **standard template for Standard Plans to report payment details** to providers. A version of the report template has been used by Standard Plans for Novant.

The Department also requires care management payment details be reported by Standard Plans through the **Encounter Processing System (EPS)**.

# Progress Update on Data Topics

## Tracking CIN-AMH Relationships

### Issue Description

**There is no standard system across PHPs to process CIN-AMH delegation changes.**

Delayed information about delegation changes can impact the timeliness of data getting to an AMH to support member care.

### Potential Solution

Create a **single source of truth** for CIN-AMH relationships and create a **standardized process** to document, maintain, and update CIN-AMH relationships.

### Current Status

The Department is developing a new **Provider Data Management/ Credentialing Verification Organization (PDM/CVO) modular system** to replace certain functions of NCTracks. The PDM/CVO module is targeted to be implemented in late 2024.

DHB has **developed internal business requirements** to incorporate CIN-AMH relationship tracking functionalities into the PDM/CVO module.

# Progress Update on Data Topics

## Patient Risk List / Risk Stratification

### Issue Description

**PHPs and AMH/CINs reported difficulty interpreting and using risk stratification information they receive due to:**

1. Variability in risk categorization (e.g., differing approaches for what qualifies as “high risk”)
2. Lack of information on how to interpret the risk categorization

### Potential Solution

The AMH TAG Data Subcommittee recommended the Department: (1) **improve the interpretation** of key terms and (2) **improve communication** of risk stratification approaches.

### Current Status

The Department is developing **Risk Stratification Guidance** to require PHPs to share descriptions of their risk stratification approaches with AMH Tier 3 practices and CINs in a standard format and manner.

The AMH TAG Data Subcommittee provided feedback on **draft Risk Stratification Guidance** earlier this year.

The Department is in the process of finalizing the Guidance. The Department will share an **implementation timeline** with the AMH TAG Data Subcommittee and other partners prior to release and enforcement of the Guidance requirements.
