Healthy Opportunities Pilot (slides 5 -14) - Amanda Van Vleet

Overview

- Pilot entities include PHPs, Care Management Teams, Network Leads, and Human Service Organizations
- Care management teams play a large role in identifying individuals who will benefit from Pliot services and connecting them to those services
- The Pilots will offer services in the following domains: Housing, Food, Transportation, Interpersonal Violence
- To qualify for pilot services, Medicaid managed care enrollees must have at least 1 needs-based criteria and at least 1 social risk factor
- All pilot enrollees will receive care management through the pilot
- No additional assessment are being created for determining eligibility
- An additional PMPM payment will be provided to care management entities for pilot enrollees
- A subset of pilot services that PHP authorization will not be required for the first 30 days. The team
 is currently working through SLAs for rapid authorization timelines for Health Plans
- Healthy Opportunities is engaging with UNC for data and monitoring.
- Healthy Opportunities is defining "Enrollment" as a member who is eligible for the pilot program and has been authorized for 1 service

NC InCK Pilot (slide 16 - 37) - Sarah Allin / Richard Chong, MD

Overview

- This new child focused stratification will elevate children for integrated care support
- "Family navigators" within AMHs will provide care management for a subset of NC InCK members with the support of NC InCK staff
- AMHs will receive actionable data on novel child-centered measures for attributed NC InCK members
- AMHs may participate in the NC InCK APM that links payment to child -centered health and wellbeing measures
- The pilot program will be based in 5 counties in NC and will be launched in 2022
- NC InCK is integrating care across core child services
- ~92,000 total children across all health plans and Medicaid Direct
- The model includes 3 Service integration Level (SIL) determined based on physical, behavioral, and developental diagnoses, the child's context, and out-of home placement
- NC InCK will integrate statewide data beyond administrative healthcare in a pediatric-focused risk model. Categories include SDOH Needs, Education, Juvenile Justice, Child Welfare, Guardian, and Medical complexity
- Children in SIL and 3 will be prioritized for care management
- Integration consultant are available to all Family Navigators who provide integrated care to InCK members in SIL 2 and 3
- Shared action plan is completed for subset of children in SIL 2 and 3 who would benefit from
 increased care integration and are at-risk of future out of home placement. Shared action plan
 completion is incentivized as a component of NC InCK's Alternative Payment Model

Wrap-up and Next Steps

- Please continue to encourage vaccination in ALL care management encounters
- DHB is preparing data on unvaccinated members to share with PHPs and AMHs by mid/end of October
- PHPs are developing COVID vaccination member incentive programs, these programs will be shared at the next AHEC managed Care Webinar
- Health Plans are working to finalize the standardized PCP Change Form
- Managed Care Quality Forum, will take place on October 12
- Tailored Care Management (TCM) Webinar will take place from October-December
