 - ii. The Risk Corridor Measurement Period is defined as:
 - 1. Period 1: July 1, 2024 to June 30, 2025.
 - 2. Period 2: July 1, 2025 to June 30, 2026.
- c. Section IV., K. Financial Requirements, 4. Risk Corridor, n. Risk Corridor for Medicaid Expansion Eligible Member Population State Fiscal Year 2025, is revised and restated as follows with no revisions to i., iii.-vi.:
 - Risk Corridor for Medicaid Expansion Populations State Fiscal Year 2025 and Subsequent Years
- d. Section IV., K. Financial Requirements, 4. Risk Corridor, n. Risk Corridor for Medicaid Expansion Eligible Member Population State Fiscal Year 2025 and Subsequent Years, ii., 1. is revised and restated in its entirety as follows:
 - 1. The Risk Corridor Measurement Period is defined as:
 - a. For Period 1: July 1, 2024 to June 30, 2025.
 - b. For Period 2: July 1, 2025 to June 30, 2026.
