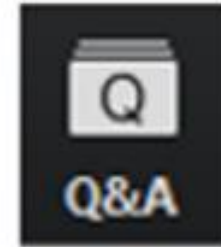

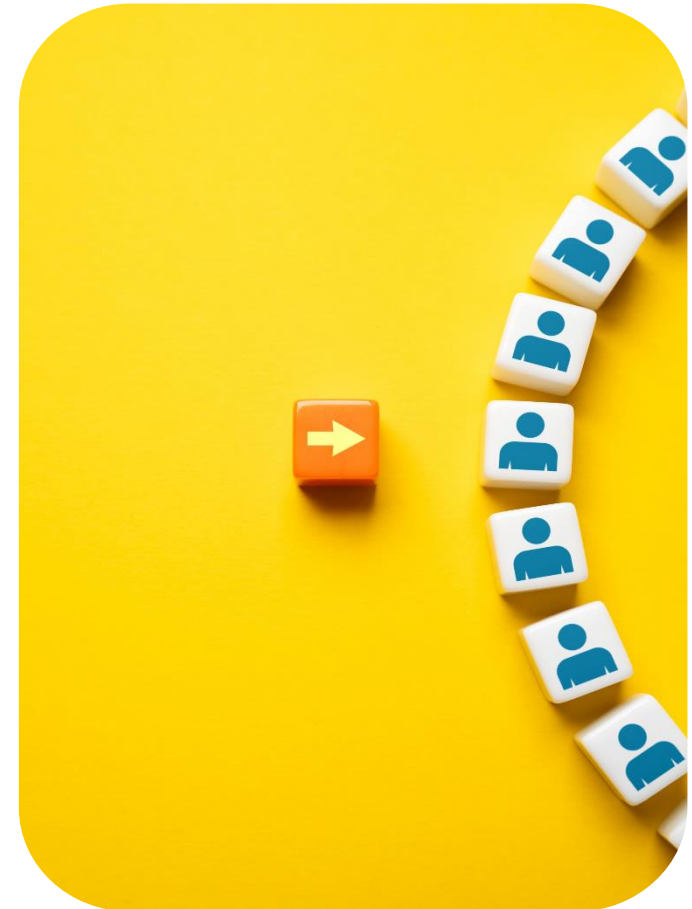

## Frequently Asked Questions

---

1

**Will the Credentialing Committee review individual providers only?**

No. The Credentialing Committee will review applications for every type of Medicaid provider.

2

**Will the Credentialing Committee impact provider turnaround time with updating status in NCTracks?**

Delays in transmission of provider enrollment file data are not expected.

3

**What metrics will determine whether a provider meets credentialing or recredentialing standards?**

Credentialing and recredentialing standards are not changing and are based on current NCQA, Federal, and State guidelines.
