Re: Insert For MPW Cards

Dear County Director of Social Services:

An insert in English will be included with the February Medicaid for Pregnant Women (MPW) identification cards informing recipients of health care services available to them through the Be Smart Family Planning Waiver (FPW) program. FPW is a Medicaid program designed to decrease unintended pregnancies and improve the well being of children and families in North Carolina by extending Medicaid eligibility for family planning services to eligible women between the ages of 19 and 55 and men ages 19 through 60 whose income is at or below 185% of the federal poverty level. The FPW program is a form of Medicaid which can provide recipients with vital coverage when their MPW coverage expires and results in cost savings to the Medicaid program as a whole. Since implementation in October 2005, Be Smart has saved the Medicaid program millions of dollars.

The FPW program can provide recipients with the following services:

- Family planning initial and yearly exams;
- Birth control and family planning counseling;
- Some types of birth control methods like the pill, the shot, and IUDs, as well as vasectomies and tubal ligations;
- Family planning lab tests, pregnancy tests and pap smears;
- Limited screening and treatment for some sexually transmitted infections and HIV testing;
