Dear County Director of Social Services:

In February 2001, new Medicaid Identification Cards were issued to Supplemental Security Income (SSI) recipients. In an effort to increase efficiency and improve security, effective June 2001, these new Medicaid Identification Cards will be issued to most other Medicaid recipients. Cash recipients and those on the straggler runs will not receive the new identification cards.

The design of the new Medicaid Identification Cards will allow information formerly provided via inserts to the cards to be printed on the paper with the card. Also, the cards will be printed using the postal bar code which is expected to improve delivery of the cards statewide. We have received reports that the SSI cards are being delivered more quickly.

The new Medicaid Identification Card will not show blue in the address window. The background will be white. Please alert your mailroom staff of the new look so that returned cards are routed appropriately. The cards will be printed on standard 8½ X 11 inch, watermarked paper. The paper will be perforated allowing recipients the ability to detach the card. However, if the recipient does not detach the card, it is still valid.

There will be no change in the way recipients use the cards. On occasion, Medicaid recipients may receive cards printed using the heavier stock paper. These cards are still valid. Counties should continue to use the heavier stock paper for issuing replacement Medicaid Identification Cards.

Medicaid recipients will receive notice regarding the new cards in May and June of 2001. Providers will be notified in the May 2001 Medicaid Bulletin and Pharmacy Newsletter. Attached for your information is a copy of the May insert and June message to be printed with the cards.
