Executive Director Steve Shore, MSW NC Pediatric Society We are writing on behalf of Governor Perdue's partnership with the NC Pediatric Society Foundation to inform you about the expansion of the *Healthy & Ready to Learn (HRL)* children's health insurance outreach and enrollment initiative. We recognize the valuable role local departments of social services play in serving the families who apply for children's health insurance programs, and we want you to be aware of the *HRL*, which was funded by the Children's Health Insurance Program Reauthorization Act (CHIPRA) in 2009 to help find and enroll eligible, uninsured children in Medicaid (Health Check) and CHIP (NC Health Choice).

Last year, school systems in 16 counties participated in outreach efforts in elementary schools to reach "uninsured and eligible" children using the information on the Kindergarten Health Assessment (KHA) form. The high-need counties chosen based on unemployment rate, poverty rate and a number of children, which piloted the initiative, were: Cleveland, Columbus, Cumberland, Davidson, Edgecombe, Gaston, Halifax, Harnett, Lenoir, Pitt, Randolph, Robeson, Rutherford, Vance, Wayne and Wilson. This year, *Healthy & Ready to Learn* intends to reach families of kindergarten students and 4-year-old children entering school in 2011 by working with school nurses, school personnel, School Health Advisory Councils (SHACs) and physician offices to promote health insurance enrollment of the uninsured

In February 2011, *HRL* began expansion in the following counties: **Alamance**, **Anson**, **Bladen**, **Brunswick**, **Buncombe**, **Burke**, **Cabarrus**, **Caldwell**, **Catawba**, **Cherokee**, **Craven**, **Duplin**, **Durham**, **Forsyth**, **Guilford**, **Iredell**, **Johnston**, **Lee**, **Martin**, **Montgomery**, **Nash**, **New Hanover**, **Onslow**, **Richmond**, **Rockingham**, **Rowan**, **Sampson**, **Scotland**, **Stanly**, **Surry**, **Union and Wilkes**.

The targeted families will receive outreach materials with income guidelines, an application and directions on how to apply. The local departments of social services in counties participating in the initiative may experience a slight increase in the HC/NCH enrollment applications. Many organizations are working together to reach out to families whose children may qualify for the programs and *HRL* is a health care initiative to contribute to this effort by targeting kindergarten students. When students are healthy, they are ready to learn, attend school regularly and sustain achievement.
