Dear County Director of Social Services:

The purpose of this letter is to inform you of the temporary reassignment of Medicaid Program Representatives. There are two vacant Medicaid Program Representative positions. Mary Simmons retires effective July 31, 2001. The death of Ken McKenzie also leaves a vacancy. In addition, Mike Winfield, the program representative currently based in Monroe, is moving to Boone effective August 1, 2001.

These changes have necessitated a shifting of counties to absorb the counties currently served by Ms. Simmons. As this is a temporary reassignment until positions can be filled, we have tried to make the change as minimal as possible. At this time we don't know when these positions may be posted or filled.

Attached you will find a listing of Medicaid Program Representatives and the counties they will serve effective August 1. We know that you will continue to work with us through this transition.
