Re: MIPPA mandates for LIS application as a Medicaid application and SHIIP outreach

Dear County Director of Social Services,

The Medicare Improvements Patient and Providers Act of 2008 (MIPPA) mandated that, effective January 1, 2010, an application for the Medicare Low-Income Subsidy (LIS) program will be considered as an application for the Medicare Savings Programs (MSP), known in North Carolina as the MQB programs. The purpose of this letter is to alert you to the upcoming changes and outreach efforts resulting from the MIPPA mandates.

Beginning January 1, 2010, the Social Security Administration (SSA) will transmit daily electronic data for each LIS application when SSA determines on an initial application that a person is eligible or not eligible for LIS. DMA will match the data with current Medicaid recipient data and create an electronic North Carolina Medicaid application for individuals who are not Medicaid/MQB recipients. The county department of social services will then be notified of the electronic application on the regular Adjusted Application Management Report. Since in North Carolina, an application for MSP is considered an application for Medicaid, the county will evaluate the individual for all possible Medicaid programs. A workgroup consisting of DMA, County DSS Medicaid, and DIRM staff have been working toward this implementation. At this time it is unclear as to the number of additional applications this may entail. More detailed information and policy changes will be forthcoming.

The SSA reported that they completed 21,889 LIS decisions for persons in North Carolina from October 2008 to June 26, 2009. This data was not provided in a form to identify numbers for each county. However, this provides a window as to the number to expect after the January 1, 2010 program implementation. The SSA also put together estimated LIS outreach targeting data to assist the SHIIP outreach efforts that attempt to identify potential LIS eligible people in each county. This data was obtained through multiple sources, including census and Medicare enrollment data, and may provide an idea as to the number of Medicaid applications to expect due to the SHIIP outreach efforts. A list is attached to this letter.

MIPPA also made available federal grant funds for the Seniors' Health Insurance Information Program (SHIIP), a division of the North Carolina Department of Insurance, to assist in helping individuals apply for LIS and Medicaid programs. In partnership with the Division of Aging and Adult Services (DAAS), Area Agencies on Aging (AAA) and the Community Resource Connections (CRSs), this fall SHIIP will launch a statewide effort, "Relay for Extra Help", to provide outreach and application assistance to persons who may be eligible for LIS and Medicaid.

The MIPPA requirements of our state agencies presents an opportunity for SHIIP and county departments of social services to work together toward increasing awareness and enrollment the LIS and Medicaid. The SHIIP coordinators and volunteers across the state are ready to assist the DSS offices. With the new initiative, SHIIP is willing to help potential recipients fill out the Medicaid application before they arrive at the local offices. Additionally, SHIIP is an excellent source of information on all aspects of Medicare, including Medicare Parts A, B, C and D, as well as private insurance sold to supplement Medicare. SHIIP coordinators and volunteers are available in every county and can provide:

- Medicare Part D one-on-one counseling, including enrollment assistance,
- Medicare Part D up-to-date information and current changes, and
- In house training on Medicare Part D to DSS staff.

In order to facilitate coordination of these MIPPA activities, please designate one person from your adult Medicaid staff as a SHIIP liaison. The liaison should work closely with the local SHIIP coordinating site in an effort to maximize all available resources, attend local SHIIP meetings to share the most updated health insurance information, and coordinate local efforts to assist Medicare beneficiaries during the application process. The DSS SHIIP liaison can provide expertise on Medicaid programs to the SHIIP Coordinators and volunteers.

Many DSS offices currently work closely with the local SHIIP staff. I encourage this relationship to continue and grow as our agencies share mutual obligations and can share the responsibilities provided by MIPPA.

Please send the county liaison contact information, email address and telephone number, to Melinda Munden at melinda.munden@ncdoi.gov. In turn, Ms. Munden will provide information on the quarterly meetings as well as the name of the SHIIP Regional Manager and Coordinator in the county. It is the desire of SHIIP to assist your agency with helping Medicare/ Medicaid beneficiaries apply for LIS and Medicaid. In addition, SHIIP wants to help these beneficiaries understand their health insurance options related to Medicare Part D as well as Medicare Advantage plans. SHIIP will also provide updates on the state's prescription drug assistance program or NCRx.
