Thanks to all the IMC workers and supervisors who helped with our survey that was included in the Dear County Director of Social Services letter dated 09/27/01. Your feedback provided us with sufficient information in determining whether or not we should keep or eliminate the paper copies of the Medicaid manuals. We put into perspective all the concerns everyone had.

Due to the budget crisis, we had to reduce the # of change notices we are currently sending to counties. For those counties receiving 5 copies, they will start receiving 3 copies. All counties without internet access will continue to receive their normal distribution.

We have encouraged all subscribers to use the online manuals. This includes paying subscribers along with free subscribers to our Medicaid manuals. Several of them have already decided to cancel their subscription and use the online manuals.

We are quite sure you are aware of the need to cut costs as much as possible. If you have any questions, please contact the Medicaid Eligibility Unit at (919) 857-4019.
