Dear county Director of Social Services:

Re: 2015 Application Monitoring

The Alexander Exit Plan requires that a county DSS be monitored annually or biannually as determined by the agency's performance on the monthly adjusted report card. All counties are monitored at least every other year; however, a county may also be monitored yearly, if they fail to meet the Average Processing Time (APT) or Percent Processed Timely (PPT) for 1 or 2 months, unless the county provides evidence that failure was beyond the control of the county. If the county fails to meet either the APT or PPT on the Adjusted Application report Card for 3 or more months in the calendar year in either report card category, the county will be monitored every year.

The monitoring sample will be pulled from NCFAST and the review period will be 12 months prior to the month monitoring begins and no earlier than December 2013. For example, a county is selected for monitoring in June 2015. The cases to be pulled will be from June 2014 through May 2015. Attached is a list of the counties that will be monitored in 2015. The monitoring process is outlined in MA-3217/MA-2305 Evaluation County/DDS Performance.
