# NC Medicaid Managed Care Services

## NC Medicaid Managed Care includes Standard Plans, Tailored Plans and the Children and Families Specialty Plan

Standard Plans and Tailored Plans are health plans that offer physical health, pharmacy, care coordination and basic behavioral health services. Tailored Plans offer care management and behavioral health services for members with a serious mental illness, severe substance use disorder, intellectual/developmental disability (I/DD) or traumatic brain injuries (TBIs).

The Children and Families Specialty Plan (CFSP), which will launch Dec. 1, 2025, is a single, statewide health plan. Those eligible for the Children and Families Specialty Plan include NC Medicaid-enrolled children, youth and young adults currently and formerly served by child welfare services. The Children and Families Specialty Plan will offer seamless physical health, pharmacy, care coordination and basic behavioral health services.

**All services are available in the EBCI Tribal Option to beneficiaries who qualify.** The EBCI Tribal Option coordinates with Vaya to provide services for serious mental illness, severe substance use disorder, I/DD or TBI services.

**Note:**

- Innovations and TBI waiver services are only available to individuals enrolled in the Innovations or TBI waiver program.

- Innovations or TBI waiver beneficiaries who are dually eligible for Medicaid and Medicare will be enrolled in a Tailored Plan.
- State-Funded services are different for each Tailored Plan.
- Tailored Care Management services are available in the Tailored Plan and NC Medicaid Direct.
- Beneficiaries on the Health Insurance Premium Payment program (HIPP) will not lose HIPP with Tailored Plan enrollment. Innovations and TBI waiver beneficiaries on HIPP will be enrolled in a Tailored Plan.
- Beneficiaries can Request to Move to Tailored Plan from the Standard Plan or Children and Families Specialty Plan if they need services only available in a Tailored Plan. Some beneficiaries may move to a Tailored Plan without a Request to Move based on their managed care status.
- Plans offer value added services to beneficiaries who qualify
