SUBJECT: Microsoft Windows XP Remediation

Dear County Director Letter number PM-REM-07-2014 (November 20, 2014) reminded counties that Microsoft Corporation ended Technical Support for the Windows XP operating system on April 8, 2014. Counties still running Microsoft XP on any computers were advised to formulate a remediation plan and replace all end-of-life-cycle software, including Windows XP, as soon as possible.

Federal and State regulations require users of State information systems and those accessing Federal data (such as IRS data) to maintain up-to-date, secure operating systems with the latest security patches installed. Failure to comply with these regulations can lead to non-compliance findings, corrective action plans and even loss of access to vital information necessary to administer service and benefit programs.

The NC Statewide Information Security Manual, Section 040207 specifically states "Each agency shall ensure that the operating systems used to run the production environment are regularly monitored for security risks and maintained in approved secure configurations to support business operations." The NC Statewide Information Security Manual can be accessed at <https://www.scio.nc.gov/Mission/InformationSecurityManual.aspx>. Any laptop or workstation still using Windows XP does not meet this standard as set forth in Section 040207.

As such, the DHHS Privacy and Security Office has escalated the urgency of this issue. **All County DSS offices are to respond to the attached survey by February 6, 2015, reporting whether any computers in use conduct NC DHHS business are still running Windows XP and, if so, a count of those machines. Do not forget to include County operated Child Support Offices.** Information from this survey will be provided to the PSO and conveyed to the DHHS CISO and the Secretary.


