

PUBLIC NOTICE
(Rate Reductions – S.L. 2014-100)

The Department of Health and Human Services, Division of Medical Assistance hereby provides notice of its intent to amend the Medicaid State Plan pages for the purpose of reducing rates by 1% in compliance with Session Law 2014-100, Section 12H.14A, for the services listed below.

This amendment will become effective January 1, 2015. The annual estimated state fiscal impact of this change is:
