## List of Currently Rebatable Polyethylene Glycol 3350 OTC Products

As announced in a [January 2019 Special NC Medicaid Pharmacy Newsletter](#), **PEG 3350 OTC products are now covered by NC Medicaid** for claims with dates of service on or after Dec. 1, 2018 when the product has a valid CMS rebate agreement on file and is prescribed for the beneficiary by a NC Medicaid enrolled provider. These pharmacy claims can be processed electronically through the point of sale (POS) system.

While pharmacists and drug wholesalers may refer to the [Medicaid Drug Rebate Program website](#) to determine if a product NDC has a valid CMS rebate agreement, NC Medicaid is providing a list of currently rebatable products to aid pharmacies in identifying OTC PEG 3350 products covered by the NC Medicaid outpatient pharmacy program.

Please keep in mind that the list below is current as of the day it was run and since the rebate status with CMS is subject to change at any time based on the manufacturer of the products, the list is only being provided this one time.
