Community Alternatives Program for Disabled Adults Waiver Application Posted for Public Comment

A draft application for § 1915 (c) Home and Community-Based Services (HCBS) Waiver for the Community Alternatives Program for Disabled Adults (CAP/DA) is posted for public comments on the NC Medicaid CAP/DA webpage through Monday, Feb. 04, 2019.

The § 1915 (c) HCBS waiver for the CAP/DA program five-year approval cycle (Oct. 1, 2013-Sept. 30, 2018) has expired. The Centers for Medicare & Medicaid Services (CMS) has granted N.C. Medicaid an extension period to continue to administer the CAP/DA waiver through March 29, 2019.

The CAP/DA unit within NC Medicaid will host informational webinars for stakeholders in Jan. 2019 to learn about the proposed changes included in the waiver application and give stakeholders an opportunity to make comments.
