The change will delete the submission of prior approval to nursing facilities via the telephone to reflect the current approval process utilized by the DHHS Utilization Review Contractor. The changes will update the list of items that can be charged to nursing facility residents to be in compliance with 42 CFR 483 Subpart B. The change will update the documentation required on the FL2 Form for admission to nursing facilities for ventilator dependent beneficiaries and to change the word "PASARR" to "PASRR". The "A" stood for annual which is no longer a federal requirement for the PASRR screening process. The final change will update the list of "Factors Frequently Indicating Need for Skilled Care" with the deletion of 13 diagnoses.
