

Dear Citizen:

In 1980 over 376,000 North Carolinians received health services through the Medicaid program at a total cost of over \$410 million. While the number of persons served has remained relatively steady, the cost of providing health care has increased dramatically. The growth in health care costs is not unique to the Medicaid Program, but is evident in all aspects of health care financing, from commercial health insurers to private paying individuals.

Institutional care, including hospitals and nursing homes, accounted for over 70% of all expenditures. Because most people prefer to remain in their own homes, and because of the high cost of institutional care, a major goal of the Division of Medical Assistance has been to encourage home-based and outpatient care. The use of Home Health Services increased during FY 1980. Home Health expenditures were up 87% over the previous year.

Financing for the Medicaid program comes from federal, state and county tax dollars. Rising Medicaid costs have strained budgets at all levels of government. Despite the increasing costs and the concerns over financing, I am confident that we will continue to meet our obligations to provide health care to the less fortunate citizens of North Carolina.

TITLE XIX

MEDICAL ASSISTANCE PROGRAM

PEOPLE SERVED ...

During the fiscal year ending September 30, 1980, 376,656 of 455,000 eligible North Carolinians received health care services through the Medicaid Program. The aged, blind and disabled categories included 135,863 people, while the remaining 240,793 people were in families with dependent children. Dependent children are those minor children who are deprived of one or both parents through absence or incapacity.

North Carolina's Medicaid program covers persons who receive payments under the Aid to Families with Dependent Children (AFDC), Special Assistance to the Blind (SAB), or State/County Special Assistance (SA) programs. Many recipients of the federal Supplemental Security Income (SSI) program are also eligible. These persons are known as Categorically Needy.

Medically Needy persons are also covered by North Carolina's Medicaid Program. These are aged, blind or disabled persons, or persons in families with dependent children, who are not eligible for a monthly cash payment, but whose incomes are insufficient to meet their medical expenses.

Coverage of the Categorically Needy groups is mandatory. Coverage of the Medically Needy groups is optional.

PROVIDERS OF SERVICE...

Medicaid payments are made to the participating health care professionals who provide medical services to eligible people. No payment is ever made to the recipient. Medicaid recipients have the freedom to choose any medical provider. Each recipient is issued a Medicaid identification card which lets the provider know he should bill his charges to the Medicaid Program.

During fiscal year 1980 10,804 providers submitted 6,344,331 claims for payment.

EARLY AND PERIODIC SCREENING, DIAGNOSIS AND TREATMENT (EPSDT) ...

North Carolina is a leading state in the percentage of eligible children screened through the EPSDT program. EPSDT is a preventive health care program for Medicaid eligible children. It is designed to identify and treat chronic conditions which can lead to disabling diseases later in life.

EPSDT screenings are provided by local health departments and participating private providers. Families are free to choose which provider will screen their children.

During fiscal year 1980 64,677 children were screened. This number is 40.1% of all eligible children.

ADMINISTRATION, CLAIMS PROCESSING AND UTILIZATION REVIEW ...

Administration of the Medicaid Program is the responsibility of the Division of Medical Assistance (DMA) in the Department of Human Resources (DHR). DMA has 121 staff positions and two major contracts.

The Claims Processing contract is held by EDS Federal Corporation. EDS Federal operates a federally approved Medicaid Management Information System (MMIS), which is a sophisticated claims processing system designed to cross-check claims for billing errors, ineligible recipients and duplicate billings.

The second major contract, also held by EDS Federal Corporation, is for utilization review. The primary emphasis of utilization review is to prevent inappropriate nursing home placements and to detect fraud and abuse by both recipients and providers. EDS Federal sends a review team to every nursing home in the state at least once a year to assess the quality of care as well as the needs of the Medicaid patients.

THIRD PARTY RECOVERY ...

North Carolina has a model Third Party Recovery program that is nationally renowned. All medical insurance, including Medicare, and all other legal medical liabilities are considered first payor before Medicaid payment can be made. During state fiscal year 1980 the Third Party Recovery Section reduced Medicaid payments \$8.7 million by seeking out third party resources. The administrative costs associated with this effort was only \$143,000. For every \$1 spent almost \$61 was collected.


FRAUD AND ABUSE CONTROL PROGRAM ...

In addition to a Fraud and Abuse Section in DMA, the state Attorney General has a staff devoted to the prosecution of Medicaid fraud in North Carolina. Recouped money tells only a small part of the story, since deterence of fraud and abuse is the most valuable contribution of these Sections.

During fiscal year 1980 \$129,644 was recouped from recipients and providers. Thirteen providers were referred to the State Attorney General for prosecution.



A HISTORY OF MEDICAID EXPENDITURES For State Fiscal Years 1971-1980





The Role of County Social Services Departments in the Medicaid Program

North Carolina has a state supervised — county administered social services system. County social services departments determine eligibility for Medicaid based on federal and state eligibility requirements. They also are required by state statutes to pay a portion of the costs for Medicaid recipients who reside in their county and receive Medicaid services throughout the year. The largest share of the costs of these services is paid by the federal government. During the 1979-80 fiscal year, the federal government paid 67.68 percent of all these costs with the exception of family planning services where it paid 90 percent. The state paid 27.47 percent and counties paid 4.85 percent of costs other than long term care. For long term care, counties paid 11.3 percent and the state 21.01 percent.
