The following are corrections to the 2006 Annual Report (4.03 MB PDF):

9	Elderly recipients comprised 10.1 percent of total recipients.
20	For SFY 2006, a total of 1,644,457 individuals were determined eligible for Medicaid.
21	Exhibit 4 indicates SFY 2006 eligibles (yearly figure) of 1,644,457.
52	a) Approximately 1,644,457 people (or 18.9 percent of the population) were eligible for Medicaid. Compared with the previous year, the state population rose by 1.6 percent; however, the number of people eligible for Medicaid increased by 5.2 percent.
52	b) The text and Exhibit 6 indicate Pregnant Women & Children at 40 percent of total eligibles.
52	c) Exhibit 6 indicates number of eligibles of 1,644,457 and includes the M-SCHIP eligibility group at 41,812 eligibles or 2.5 percent of total eligibles. The percent of total eligibles figures for the other eligibility categories are adjusted accordingly.
53	Exhibit 7 indicates number of eligibles of 1,644,457 and includes the M-SCHIP eligibility group with an increase of 41,812 eligibles.
54	a) Exhibit 8 "By Eligibility Category" includes the M-SCHIP eligibility category at 2 percent of total eligibles and adjusts the percentages of the other categories accordingly.
54	b) The text related to Elderly recipients indicates that Elderly recipients comprised 10.1 percent of total recipients.
54	c) Exhibit 11 shows that expenditures per recipient increased during SFY 2006 for the Elderly and Disabled, remained unchanged for Families & Children and decreased for Aliens & Refugees.
55	Exhibit 9 indicates Elderly at 10.1 percent of total recipients.
56	Exhibit 11 indicates SFY 2006 Elderly expenditures per recipient of \$12,441 (17.1% increase) and Families & Children expenditures per recipient of \$2,198 (unchanged).
67	Table 7 includes the M-SCHIP eligibility category at 41,812 individuals and total eligibles of 1,644,457, which is a 5.16 percent change. The SFY 2006 percent of total eligibles for all categories have been changed accordingly.
69	Table 8 indicates number of Medicaid eligibles of 1,644,457, expenditures per eligible of \$4,808, eligibles per 1,000 population of 189 and percent of Medicaid eligibles at 18.94 percent of the total population.
