Description: High Fidelity Wraparound (HFW) is an intensive, team-based, person-centered service that provides coordinated, integrated, family-driven care to meet the needs of youth/young adults who are involved with multiple systems (e.g. mental health, child welfare, juvenile/criminal justice, special education); experience serious emotional or behavioral difficulties; have dual diagnosis (MH and/or SUD, and IDD) with complex needs; are at risk of treatment in PRTFs or other institutional settings; who have been in restrictive residential/institutional care; and/or are aging out of Department of Social Services (DSS) care.

## Other Requirements:

All other terms and conditions as set forth in the original contract document shall remain in effect for the duration of this Agreement.
