#### **Provider Contract Templates – Payment Provisions**

- PHP Contract Section VII Attachment G.1.g. requires templates to contain a provider payment provision that describes the methodology to be used as a basis for payment to the provider.
- The Department interprets this provision to require the PHP to include specific statements relating to payment for certain provider types as found in PHP Contract Section V.D.4. as applicable.
  - This includes specific provisions relating to or explaining:
    - Rate floors
      Rate Methodologies
    - Rate schedules
      AUDP\*
- PHPs were to compare all currently approved or pending provider contract templates against PHP Contract Sections V.D.4.d. through p. (FQHC's subsection is V.D.4.g.) and make all necessary changes to templates to include the appropriate required provision(s).

#### **FQHC** Payment Provisions from PHP Contract

- g. Federally-Qualified Health Centers (FQHCs)/Rural Health Centers (RHCs) Payments
  - i. The PHP shall reimburse FQHCs and RHCs for covered services at no less than the following rates:
    - a) All ancillary services (i.e. radiology, etc.) shall be the based on the North Carolina Medicaid Physician Fee Schedule.
    - b) All core services shall be based on each FQHC or RHC's respective North Carolina Medicaid Fee Schedule, which is defined as each FQHC or RHC's respective core rate or T-1015 code.
