# 1.0 Description of the Procedure, Product, or Service

The terms rRhinoplasty, septoplasty, and septorhinoplasty are surgical procedures that may be performed for cosmetic or reconstructive purposes.

e sometimes used interchangeably, but they have distinct meanings. A *rhinoplasty* is cosmetic or reconstructive surgery done to alter the contours of the nose itself without involvement of the underlying nasal septa. A *septoplasty*, on the other hand, involves only the septum. However, in clinical practice, a surgical procedure sometimes involves elements of both a rhinoplasty and a septoplasty. This is referred to as a *septorhinoplasty*, a more extensive procedure combining repairs to the external nasal pyramid or skeleton with repairs of the nasal septa in order to correct a functional impairment involving both structures. This may involve correcting damage or functional deficits that result from disease, surgery, or trauma. The surgery may also be performed to correct a congenital defect such as a cleft lip or palate.

#### 1.1 Definitions

#### Rhinoplasty

This is a cosmetic or reconstructive surgery done to alter the contours of the nose without the involvement of the underlying nasal septa. It can correct impaired breathing caused by structural defects in the nose.

#### **Septoplasty**

<u>Involves only the septum, the procedure is used to correct deformities of the nasal septum.</u>

#### **Septorhinoplasty**

A more extensive procedure combining repairs to the external nasal pyramid or skeleton with repairs of the nasal septa to correct a functional impairment involving both structures. This may involve correcting damage or functional deficits that result from disease, surgery, or trauma. Surgery may also be performed to correct a congenital defect.

# 2.0 Eligibility Requirements

#### 2.1 Provisions

#### 2.1.1 General

(The term "General" found throughout this policy applies to all Medicaid policies)

- a. An eligible beneficiary shall be enrolled in the NC Medicaid Program (Medicaid is NC Medicaid program, unless context clearly indicates otherwise).
- b. Provider(s) shall verify each Medicaid beneficiary's eligibility each time a service is rendered.
- c. The Medicaid beneficiary may have service restrictions due to their eligibility category that would make them ineligible for this service.

(The term "Specific" found throughout this policy only applies to this policy)

## 2.2 Special Provisions

# 2.2.1 EPSDT Special Provision: Exception to Policy Limitations for a Medicaid Beneficiary under 21 Years of Age

a. 42 U.S.C. § 1396d(r) [1905(r) of the Social Security Act]

Early and Periodic Screening, Diagnostic, and Treatment (EPSDT) is a federal Medicaid requirement that requires the state Medicaid agency to cover services, products, or procedures for Medicaid beneficiary under 21 years of age **if** the service is **medically necessary health care** to correct or ameliorate a defect, physical or mental illness, or a condition [health problem] identified through a screening examination (includes any evaluation by a physician or other licensed practitioner).

This means EPSDT covers most of the medical or remedial care a child needs to improve or maintain his or her health in the best condition possible, compensate for a health problem, prevent it from worsening, or prevent the development of additional health problems.

Medically necessary services will be provided in the most economic mode, as long as the treatment made available is similarly efficacious to the service requested by the beneficiary's physician, therapist, or other licensed practitioner; the determination process does not delay the delivery of the needed service; and the determination does not limit the beneficiary's right to a free choice of providers.

EPSDT does not require the state Medicaid agency to provide any service, product or procedure:

- 1. that is unsafe, ineffective, or experimental or investigational.
- 2. that is not medical in nature or not generally recognized as an accepted method of medical practice or treatment.

Service limitations on scope, amount, duration, frequency, location of service, and other specific criteria described in clinical coverage policies may be exceeded or may not apply as long as the provider's documentation shows that the requested service is medically necessary "to correct or ameliorate a defect, physical or mental illness, or a condition" [health problem]; that is, provider documentation shows how the service, product, or procedure meets all EPSDT criteria, including to correct or improve or maintain the beneficiary's health in the best condition possible, compensate for a health problem, prevent it from worsening, or prevent the development of additional health problems.

#### b. EPSDT and Prior Approval Requirements

- a. If the service, product, or procedure requires prior approval, the fact that the beneficiary is under 21 years of age does **NOT** eliminate the requirement for prior approval.

# 3.0 When the Procedure, Product, or Service Is Covered

#### 3.1 General Criteria Covered

Medicaid shall cover the procedure, product, or service related to this policy when medically necessary, and:

- a. the procedure, product, or service is individualized, specific, and consistent with symptoms or confirmed diagnosis of the illness or injury under treatment, and not in excess of the beneficiary's needs;
- b. the procedure, product, or service can be safely furnished, and no equally effective and more conservative or less costly treatment is available statewide; and
- c. the procedure, product, or service is furnished in a manner not primarily intended for the convenience of the beneficiary, the beneficiary's caretaker, or the provider.

# 3.2 Specific Criteria Covered

## 3.2.1 Specific criteria covered by Medicaid

Medicaid shall cover rhinoplasty and septoplasty procedures when the beneficiary meets the following criteria:

## Rhinoplasty

- a. Medicaid shall cover rhinoplasty /septoplasty procedures when any of the following criteria are met:
  - <u>Nasal</u> dDeformity secondary to a congenital cleft lip, palate or other another congenital craniofacial deformity causing a functional impairment. defect of the nose.
  - 2. Reconstruction following removal of a nasal malignancy, an abscess, or osteomyelitis that has caused severe deformity and breathing difficulty.
  - 3. Significant d Deformity caused by specifically documented trauma within the previous 18 months.

## **Septoplasty**

- b. Medicaid shall cover septoplasty procedures when **any** of the following criteria are met:
  - 1. Septal deviation that causesing continuous nasal airway obstruction, resulting in nasal breathing difficulty that does not respond to appropriate medical therapy.
  - 2. Four or more documented episodes of recurrent sinusitis in the last 365 days of Documented recurrent with exacerbations secondary felt to be due to a deviated septum that do not resolve after appropriate medical and antibiotic therapy.
  - 3. Four or more documented episodes of Recurrent recurrent epistaxis with exacerbations related to a septal deformity.
  - 4. <u>Septoplasty performed in association with a cleft lip or a cleft palate</u> repair.
  - 5. Asymptomatic septal deformity that prevents access to other intranasal areas when such access is required to perform medically necessary surgical procedures.
  - Deformities of the bony nasal pyramid that directly cause significant and symptomatic airway compromise, sleep apnea, or recurrent or chronic rhinosinusitis when these conditions are not responsive to appropriate medical management.

#### 3.2.2 Medicaid Additional Criteria Covered

# 4.0 When the Procedure, Product, or Service Is Not Covered

#### 4.1 General Criteria Not Covered

Medicaid shall not cover the procedure, product, or service related to this policy when:

- a. the beneficiary does not meet the eligibility requirements listed in Section 2.0;
- b. the beneficiary does not meet the criteria listed in Section 3.0;
- c. the procedure, product, or service duplicates another provider's procedure, product, or service; or
- d. the procedure, product, or service is experimental, investigational, or part of a clinical trial.

# 4.2 Specific Criteria Not Covered

# 4.2.1 Specific Criteria Not Covered by Medicaid

Medicaid shall not cover Rhinoplasty and Septoplasty procedures are not covered when they are performed:

- a. to improve appearance; instead of primarily to restore bodily function or to correct a significant deformity caused by congenital anomaly, injury, disease, or growth and development that resulted in significant functional impairment or disfigurement; or
- b. more than 18 months after the documented trauma that caused the significant deformity.

#### 4.2.2 Medicaid Additional Criteria Not Covered

# 5.0 Requirements for and Limitations on Coverage

# 5.1 Prior Approval

Medicaid shall require prior approval is required for most rhinoplasty and septoplasty procedures. The provider shall obtain prior approval before rendering rhinoplasty and septoplasty procedures. Refer to Attachment A, Letter C for the list of prior approval procedures.

# 5.2 Prior Approval Requirements

#### 5.2.1 General

The provider(s) shall submit to the Department of Health and Human Services (DHHS) Utilization Review Contractor the following:

- a. the prior approval request; and
- b. all health records and any other records that support the beneficiary has met the specific criteria in **Subsection 3.2** of this policy.

# 5.2.2 Specific

The <u>rendering</u> provider(s) shall submit to NC Medicaid's <u>designee</u> <u>vendor</u> the following:

- a. the prior approval request; and
- b. all health care records and any other records that support the beneficiary has met the specific criteria in **Subsection 3.2.1** of this policy including:
  - 1. Location and cause of the defect or deformity;
  - 2. Pre-operative medical photographs of the defect consisting of frontal, lateral, and columellar reviews. Medical photographs should be clearly marked with:
    - A. the beneficiary's first and last name;
    - B. the beneficiary's identification number;
    - C. the provider's name and NPI;
    - D. and the date the photographs were taken;
  - 3. A 1 Listing of the CPT codes describing the procedure to be performed;
  - 4. Documentation of frequency, severity, and description of symptoms;
  - 5. Documentation of the number of sinus infections that have occurred in the last 365 days when applicable;
  - 6. <u>Documentation of the number of episodes of epistaxis that have occurred</u> when applicable;
  - 7. Bodily function that will be improved or restored;
  - 8. Medical records documenting the history of the trauma or injury (if applicable), with the date of injury and any other related surgeries;
  - 9. Documentation of sleep apnea and/or symptoms of breathing obstruction, if applicable, including consecutive treatment rendered; and
  - 10. Postoperative plan of care.

**Note:** If the Medicaid beneficiary is under 21 years of age, information supporting that all EPSDT criteria are met and evidence-based literature supporting the request, if available.

# 5.3 Additional Limitations or Requirements

None Apply.

# 6.0 Provider(s) Eligible to Bill for the Procedure, Product, or Service

To be eligible to bill for the procedure, product, or service related to this policy, the provider(s) shall:

- c. meet Medicaid qualifications for participation;
- d. have a current and signed Department of Health and Human Services (DHHS) Provider Administrative Participation Agreement; and
- e. bill only for procedures, products, and services that are within the scope of their clinical practice, as defined by the appropriate licensing entity.

Provider(s) shall refer to the applicable edition for the code description, as it is no longer documented in the policy.
