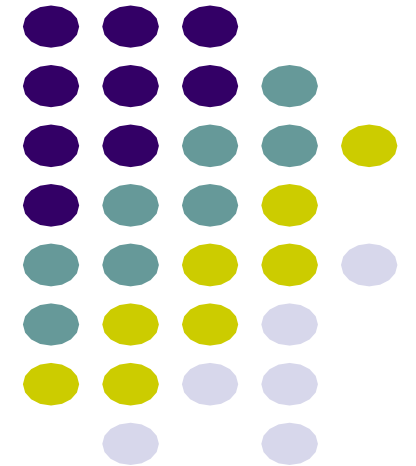


Patient Volume Reporting Periods

Attesting for Program Year 2021



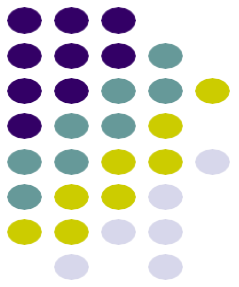


Patient Volume Reporting Periods

- EPs have until Oct. 31, 2021 to submit a Program Year 2021 attestation.
- There are two options for your patient volume reporting period:
 - Pull patient volume from the calendar year prior to the program year (i.e. calendar year 2020 for Program Year 2021)
 - Pull patient volume from the 12 months preceding the attestation

PV Reporting Periods – Option 1

Example: Attesting for PY 2021 on 5/3/2021



2020



Choose any consecutive 90-day period from the calendar year prior to the program year.

For example, if you were to attest on May 3, 2021 for Program Year 2021, you can select any consecutive 90-day reporting period from January 1, 2020 through December 31, 2020.

PV Reporting Periods – Option 2

Example: attesting for Program Year 2021 on 5/3/2021

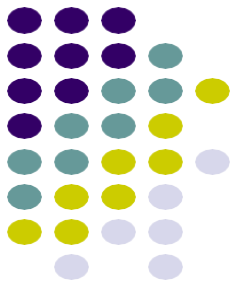

Any consecutive 90 days in the 12 months preceding attestation: May 3, 2020 – May 2, 2021 (highlighted dates)

PV Reporting Periods – Option 2 Cont'd

Example: attesting for Program Year 2021 on 5/3/2021



- If you attest on May 3, 2021 for Program Year 2021, you can select any consecutive 90-day reporting period from the 12 months preceding attestation. That's May 3, 2020 through May 2, 2021.
- Keep in mind that the closer your reporting period is to the date of your attestation, the more likely your payment will be delayed. This is because we use paid claims to validate the numbers of encounters you attest to, so claims lag would be a major factor.

PV Reporting Periods



Remember, three months does not necessarily equal 90 days.

$$31 + 28 + 31 = 90$$

Regardless of the option you choose, the reporting period must be EXACTLY 90 days.



PV Reporting Period \neq MU Reporting Period



The PV reporting period can be different from the MU reporting period.

Your MU reporting period will be any consecutive 90-day period between Jan. 1, 2021 and Oct. 31, 2021.
