## More North Carolinians can get health care coverage through Medicaid.

- North Carolina is providing health care coverage to more people through Medicaid.
- Medicaid now covers people ages 19 through 64 years with higher incomes.
- You may be able to get Medicaid even if you didn't qualify before.
- Medicaid pays for doctor visits, yearly check-ups, emergency care, mental health and more – at little or no cost to you.



# Coverage through Medicaid lets you get the health care you need.

## Medicaid covers most health services, including, but not limited to:

- **primary care** so you can go to a doctor for a check-up or when you are not feeling well
- **hospital services** when you need to stay overnight (inpatient) or when you can go home the same day (outpatient)
- **maternity and postpartum care** if you are pregnant and after giving birth
- **prescription drug benefits** to pay for your medicines
- **behavioral health**
- **preventive** and wellness services
- **dental** and oral health services
- **medical-related devices** and other therapies

# More North Carolinians are now eligible.

People 19 through 64 years old with income up to 138% of the Federal Poverty Level.

Family Size	2024 Monthly Income* (before taxes)
Single Adults	\$1,732 or less
Family of 2	\$2,351 or less
Family of 3	\$2,970 or less
Family of 4	\$3,588 or less
Family of 5	\$4,207 or less
Family of 6	\$4,826 or less

*\*Income limits are updated annually.*



**Include these people in your family size, even if they do not need Medicaid:**

- You
- Your spouse
- Your children under 21, including stepchildren
- Any other person on the same federal income tax return

**Exceptions:**

- If you are over 21, do not include your parents who live with you and file their own tax return
- Do not include other adult relatives who file their own tax return

# If you were eligible for Medicaid before, you still are.

Children, pregnant women, older adults, people with blindness and people with disabilities who meet the criteria below are eligible for Medicaid.

<b>Children</b>	<b>Family size of 1 - \$2,649</b> <b>Family size of 2 - \$3,595</b> <b>Family size of 3 - \$4,541</b>
<b>Pregnant Person</b>	<b>Family size of 1 - \$3,339</b> <b>Family size of 2 - \$4,218</b> <b>Family size of 3 - \$5,096</b>
<b>•Older Adults over 65</b> <b>•People with blindness</b> <b>•People with disabilities</b> <b>*Asset limits also apply</b>	<b>Family size of 1 - \$1,255</b> <b>Family size of 2 - \$1,704</b>

Monthly income limits are based on family size.

If someone in your family is pregnant, do not include the unborn child for this chart.

# Are immigrants eligible for Medicaid?

Some non-U.S. citizens can get health coverage through Medicaid.

**To be eligible you must be:**

- A person living in North Carolina
- A non-citizen with qualified immigration status. Most people must wait five years. Qualified immigration status includes:
  - Lawful Permanent Residents (LPR/Green Card Holder)
  - Asylees
  - Refugees
  - Cuban/Haitian entrants
  - Paroled into U.S. for at least one year
  - Conditional entrant granted before 1980
  - Battered non-citizens, spouses, children or parents
  - Victims of trafficking and his or her spouse, child, sibling or parent or individuals with a pending victim of trafficking visa application
  - Granted withholding of deportation
  - Member of a federally recognized Indian tribe or American Indian born in Canada
  - Citizens of the Marshall Islands, Micronesia and Palau who are living in one of the U.S. states or territories (referred to as Compact of Free Association or COFA migrants)



# Temporary Health Coverage for Emergency Conditions

Non-citizens without documents who do not qualify for full health coverage under Medicaid may be able to get temporary coverage for emergency conditions that need to be treated in an emergency room.

## Immigration Status and Eligibility for Medicaid Expansion

NC Medicaid now covers people ages 19 through 64 with higher incomes. You may be able to get health care coverage through Medicaid even if you did not qualify before. Medicaid pays for doctor visits, yearly check-ups, emergency care, dental care, mental health and more - at little or no cost to you.

As of December 1, 2023, most people can get health care coverage through NC Medicaid if:

- You live in North Carolina
- You are ages 19 through 64
- You are a citizen (some non-U.S. citizens can also get health care coverage through Medicaid).
- And if your household monthly income falls within the chart below:

Household Size	2024 Monthly Income*
Single Adults	\$1,732 or less
Family of 2	\$2,351 or less
Family of 3	\$2,970 or less
Family of 4	\$3,588 or less
Family of 5	\$4,207 or less
Family of 6	\$4,826 or less

*\*Income limits are updated annually.*

Some of the non-U.S. citizens on the list above do NOT have to wait 5 years to be eligible for Medicaid, including pregnant women, children under the age of 19, asylees, refugees, victims of trafficking, Cuban-Haitian Entrants, and people who now have LPR status and who were previously asylees, refugees, victims of trafficking, or Cuban-Haitian entrants. Also, all non-citizens from the list above who are connected to the military such as veterans, active-duty military (and their spouses and children) do not have to wait five years for Medicaid eligibility. All other non-citizens in the list above must wait five years from the time of receiving their qualified immigration status to be eligible for Medicaid.

**If none of the qualified immigration statuses listed above apply to you:**

If you are not a U.S. citizen or part of these immigration categories, but you would otherwise qualify for NC Medicaid, you may still apply to get emergency coverage that includes:

- **Payment for the costs of childbirth.** Get coverage for medical costs during labor and delivery. You can apply up to three months after birth.
- **Payment for emergency services.** Get coverage for the medical costs of treating an emergency, like a heart attack, stroke, or serious accident. You can apply up to three months after the emergency.

## How much does Medicaid cost me?

- You do not have to pay any monthly premiums.
- Medicaid pays the cost for most health care services.
- The highest copay is \$4 and that is only required on some services.



# What information do I need to apply?

**It takes time to complete the application. Here is some of the information you will be asked to provide for each person applying:**

- Full legal name
- Date of birth
- Social Security number (or immigration documents)
- North Carolina residency (mailing address)
- Income information (from paystubs, W-2 forms, tax returns or business records)
- Your signature (digital, voice or written depending on how you apply)

North Carolina uses external resources to verify the information you provide. If more information is needed, you will receive a letter in the mail from your local Department of Social Services (DSS).

# What documents can be used if DSS asks for more information?

<b>North Carolina Residency</b>	<ul style="list-style-type: none"> <li>• A photo ID with your NC address listed, or</li> <li>• A utility bill, or</li> <li>• A lease or mortgage agreement, or</li> <li>• Documentation of employment, or</li> </ul> <p>If you do not have any documentation, you can check a box in ePASS labeled “NC Residency Declaration.”</p>
<b>Income Information</b>	<ul style="list-style-type: none"> <li>• If you’re <b>Employed</b> - pay stubs, employer verification or your most recent tax return to show proof of your income.</li> <li>• If you’re <b>Self-Employed</b> - your most recent tax return or copies of your business records. If you don’t have that, you can fill out a <a href="#">Verification Form for Self-Employment Income and Expenses</a> form.</li> </ul>
<b>Date of Birth</b>	<ul style="list-style-type: none"> <li>• A photo ID with your date of birth listed, or</li> <li>• Birth certificate.</li> </ul>
<b>Social Security Number</b>	<ul style="list-style-type: none"> <li>• A copy of your Social Security card or proof you’ve applied for one, or</li> <li>• Another official document containing your name and SSN, or</li> <li>• A military ID card.</li> </ul>
<b>Citizenship</b>	<ul style="list-style-type: none"> <li>• Birth Certificate, or</li> <li>• Passport.</li> </ul>
<b>Immigration Documents</b>	<ul style="list-style-type: none"> <li>• A copy of your VISA/immigration card.</li> </ul>

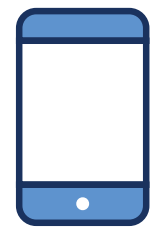

# After I apply, how long does it take to find out if I can be covered through Medicaid?

It may take up to 45 days after you apply. Incomplete applications may take longer.

**You can help the process go faster by:**

- **Applying online at ePASS or HealthCare.gov and providing all information requested.** If the application is incomplete, it may take longer to process. Your local Department of Social Services (DSS) will reach out to you if they do not have what is needed to complete your application, so be sure to respond to mail or phone calls.
- **Keeping your contact information up to date in ePASS, so you don't miss important information about your Medicaid benefits.**
  - **Sign up for an enhanced ePASS account.** An enhanced ePASS account allows you to keep your information updated without having to contact the local DSS office.

# What happens once I'm approved?

- Most people who get health coverage through Medicaid are part of NC Medicaid Managed Care. This means you can choose the health plan that is best for you.
- All health plans offer the same base services. Some have extra services. Each has its own network of doctors and professionals.
- You can choose your health plan and your primary care doctor - your family doctor, clinic or health care provider - when you apply.
- You will receive a health plan ID card in the mail. It will come from the health plan that you selected during the application process. If you did not select a health plan, one will be assigned to you. You have 90 days to pick a new one. You will receive a packet from the NC Medicaid Enrollment Broker that tells you how to change plans.
- Your ID card also has the name of your primary care doctor. If you did not choose one when you applied, one will be assigned to you.

## What if I'm still not eligible?

- You can find out if you are eligible for Medicaid and apply through **ePASS** or **HealthCare.gov**.
- If you still are not eligible for health coverage through Medicaid, you may be able to get other health coverage options through the Affordable Care Act Marketplace at HealthCare.gov.
  - Many households that apply may be eligible for help to pay for their premiums.
- If you don't have health insurance, you can also get basic health care services at federally qualified health centers, rural health clinics and free and charitable clinics.
