Effective with date of service Jan 5, 2021, the Medicaid and NC Health Choice programs cover rituximabarrx injection, for intravenous use (Riabni™) for use in the Physician Administered Drug Program (PADP) when billed with HCPCS code J3590 - Unclassified biologics. More

<u>Lumasiran Injection, for Subcutaneous Use (Oxlumo™) HCPCS Code J3490: Billing Guidelines</u> TUESDAY, FEBRUARY 9, 2021

Effective with date of service Dec. 22, 2020, the Medicaid and NC Health Choice programs cover lumasiran injection, for subcutaneous use (Oxlumo™) for use in the Physician Administered Drug Program (PADP) when billed with HCPCS code J3490 - Unclassified drugs. More

Effective April 1, 2021, as part of the transition to Medicaid Managed Care, NC Medicaid will offer timelimited payment to practices that have attested into Advanced Medical Home Tier 3 if they can demonstrate successful readiness for AMH Tier 3 responsibilities. More
