## Network Adequacy Metrics

Metric	Definition
% of Members in Region Meeting Access Standards	The percentage of members in a region whose residential address is within the specific time or distance of the appropriate number of providers for the specified service type.

## Global Adjustments to Time & Distance Standards

Explanation
Because geo-mapping analysis of the NC Medicaid Fee-For-Service provider network resulted in some counties not meeting the applicable network adequacy standards for certain provider/service categories for certain member age groups (adult or child), the Department adopted adjusted time and distance standards for certain county/provider category/beneficiary combinations. The results in this report DO NOT reflect the results based upon those adjusted standards. <b>This mean that the displayed results in some instances reflect a percentage of members with access that is less than the result when the adjusted standards are used.</b>
