### NC Medicaid Updates (slides 7-8) – Eumeka Dudley

The Department reemphasized that Medicaid Expansion will launch on December 1, 2023. If providers are in contact with potentially <u>eligible individuals</u>, then can encourage them to apply online. Newly enrolled members can select a PCP (<u>PCP choice info</u>). Members will be assigned a Tailored Care Management provider but can request a change from their plan.

#### **Tailored Care Management Success Stories**

The Department shared two Tailored Care Management success stories. See the <u>October TAG</u> slides for the two stories shared by Primary Care Solutions and ComServe.

#### Innovations Waiver Waitlist Dashboard

The Department created an <u>Innovations Waiver Waitlist</u> dashboard, which will show waitlist numbers by Local Management Entities/Managed Care Organizations (LME/MCOs) and by county. The Department will update the dashboard with the previous month's data by the 30<sup>th</sup> of each month.

# Tailored Care Management Certification Update

The Department provided additional detail on the Tailored Care Management recertification and contract termination processes for Advanced Medical Home Plus (AMH+) practices and Care Management Agencies (CMAs). There is no recertification process for AMH+s/CMAs. LME/MCOs will continue to provide oversight and monitoring of AMH+s/CMAs and if an LME/MCO identifies a compliance issue, the AMH+/CMA will be given the opportunity to correct under a Corrective Action Plan (CAP). If the AMH+/CMA does not correct the issue during the remediation period, then the LME/MCO can terminate its contact with the AMH+/CMA.

One provider asked if there will be a standard process for oversight and monitoring.

• The Department responded that they are developing a standard monitoring tool and will share additional information once it becomes available.

# Healthy Opportunities Pilot (HOP) Care Manager Training Series

The Department highlighted the Health Opportunities Pilot (HOP) care manager training series schedule, which consists of a series of live training sessions and self-paced online modules. #### Proposed Tailored Care Management Auto Assignment Changes

The TCM Auto Assignment Collaborative has identified two auto assignment changes to minimize reassignments and disruptions in care management:

- 1. Allowing members to stay with their assigned providers, with some exceptions, when their population segment changes. *Note: auto assignment due to member's population segment changes has been paused since mid-August.*
- 2. Removing the two-year look-back period for members receiving Home and Community-Based Services (HCBS) services, which will allow AMH+s/CMAs who previously but no longer deliver HCBS to serve as a member's Tailored Care Management provider.

One provider asked the timeline for these auto assignment changes to be implemented.

• The Department is currently going through the governance process to get these changes approved and will notify the TAG once it is finalized. In parallel, the Department is updating the auto assignment policy documents and LME/MCOs are working to make changes to their software.

One TAG member asked if the Department has a process for providers to share ideas for additional auto assignment changes.

• The Department recommended providers submit ideas to the Tailored Care Management email address (Medicaid.TailoredCareMgmt@dhhs.nc.gov).

#### Additional Tailored Care Management Updates

The Department provided additional Tailored Care Management updates:

- The Department is analyzing the provider rate assumption survey results (which had an 81% response rate) and will share with the TAG once finalized.
- The TCM Member Education and Community Awareness Workgroup created social media content that will be shared in the coming weeks.

The Department thanked the TAG for submitting potential TAG meeting topics. The Department is considering how best to advance the submitted topic of standardization across LME/MCOs. The Department asked TAG members to share their thoughts on LME/MCO standardization or other potential TAG topics they would like to see covered.

TAG members shared the following suggestions as it relates to standardization:

• One TAG member suggested that in instances in which all LME/MCOs will be requesting information from AMH+s/CMAs that they use a standardized method of requesting that information (e.g., capacity building funds reporting).

• Multiple TAG members suggested the Department conduct a survey to identify a list of items that would be beneficial if they were standardized across LME/MCOs and then determine the prioritization of the list.

TAG members shared the following suggestions as it relates to other TAG meeting topics:

- How to handle unengaged members.
- Work force challenges, including addressing shortages in care managers and inequity in pay across LME/MCOs and AMH+s/CMAs.
- Supporting non-Tailored Care Management providers in understanding and being prepared to serve members with 1915(i) services.
