**Re: DSS Tailored Plan Train the Trainer Registration**

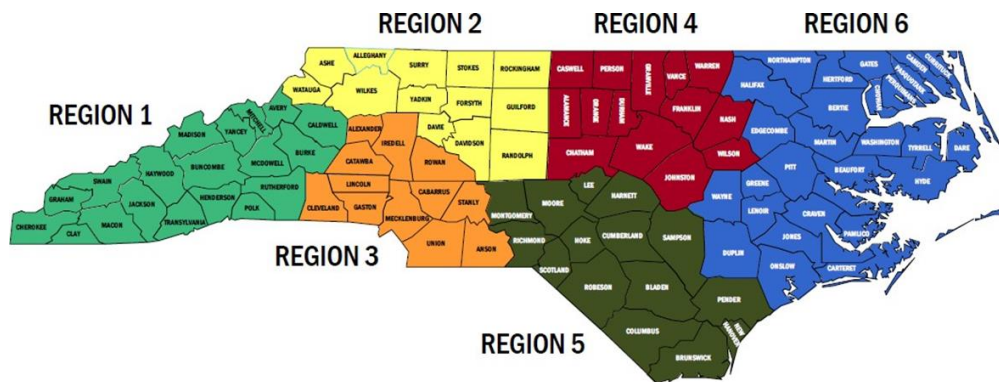
Dear County Director of Social Services:

**Your response for who will be attending is requested no later than 5/20/2022.**


